

NOW! More Than Ever!

Women continue to face severe challenges to their rights.

- Women's constitutional right to privacy and the option to choose abortion freely and have access to safe, effective birth control including over-the-counter EC (emergency contraception) remain under relentless attack.
- The U.S. Supreme Court ruling of 2007 to deny a woman and her doctor the right to make decisions on mid-term abortion procedures to protect her health has taken us a step backward. *Roe v. Wade* remains fragile and the Court is poised to reverse this 1973 ruling.
- Reproductive health clinics and health centers have been subjected to acts of terrorism, and workers and clients continue to be harassed, threatened, and murdered. A huge threat to women's access to abortion services exists since 87 percent of counties in the United States have no abortion provider.
- Violence against women and children continues while funds for shelters and aid-to-victims programs have been cut.
- Employment discrimination still flourishes. Women still earn only 80¢ for every dollar earned by men. Yet, the Supreme Court has made decisions that seriously cut back anti-discrimination laws and state and national affirmative action is effectively compromised. We continue to fight for Equal Pay and an end to the glass ceiling in the workplace.
- Social Security, pension plans, and credit institutions still do not recognize the economic value of the labor of full-time homemakers when divorced or widowed.

National Purposes

NOW, the first civil rights group for women, began in 1966 to:

- Gain true equality for all women—toward an equal partnership of the sexes.
- Bring women into full participation in American society—politically, economically, socially, and educationally.
- End employment discrimination.
- Ensure freedom of choice in abortion and birth control.
- Achieve recognition for the economic and social value of homemaking and child care.

Local Purposes

Our ACT NOW chapter began in 1974 as Tri-Valley NOW and has continued to take action locally to support:

- Safe and legal abortion, reproductive health care and education, and the availability of effective birth control
- The elimination of sex-based wage and employment discrimination
- Adequate, affordable, quality child care and paid job-secured parental leave
- Equal education and Title IX enforcement
- Freedom for lesbian/gay/bisexual/transgender people to responsibly determine their own lifestyles, having protection against discrimination and having the full rights and responsibilities of marriage
- Freedom from sexual harassment
- A federal Equal Rights Amendment

Chapter Activities

We take grassroots action to protect and further women's rights by:

- ✓ Petitioning, picketing, letter writing, providing speakers to the community, and other public awareness actions such as organizing the Clothesline Project, a display of T-shirts bearing anti-violence messages.
- ✓ Working through our Political Action Committee: The PAC seeks, supports, and endorses feminist candidates for local office.
- ✓ Lobbying legislators at all levels of government.
- ✓ Displaying resource materials on women's issues at events, public libraries, and schools.
